1.1. 1.2. UMthetho ubeka izidiso zenqubo ezhambisana nezicelo zolwazi, izidiso okufanele izicelo zihlangabezane nazo kanye nezizathu zokwenqaba izicelo.

1.3. Umthetho futhi uyaqaphela ukuthi ilungelo lokufinyelela olwazini kufanele lilingane namanye amalungelo futhi kufanele libe ngaphansi kwemikhawulo ehlanganisa, kodwa ingacini nje, imikhawulo ehloselwe ukuvikela okufanelekile kobumfihlo kanye nokugcinwa kuyimfihlo kwezohwebo.

7. INQUBO YOKUCELA

7.1. Umfakisicelo odinga ukufinyelela olwazini oluphethwe yiNhlango kufanele enze leso sicelo ngendlela enqunyiwe bese ehambisa isicelo, kanye nemali enqunyiwe kanye nemali

ekhokhwa kuqala, kuSikhulu Esibhekele Ulwazi seNhlanguano ekhelini leposi noma lendawo njengoba kushiwo esigabeni 2. ngenhla.

Ngokuya ngamalungelo eNhlanguano aphathelene nanoma yikuphi ukwelulwa njengoba kubekwe eMthethweni ophathelene nokwandiswa ngokoMthetho, izocubungula isicelo zingakapheli izinsuku ezingama-30 (amashumi amathathu) yamukelwe isicelo ngaphandle uma umfakisicelo ehambise izizathu ezikhethekile eNhlanganweni, okuvumelekile, okusekelayo inhlanguano ukuthi lezi zikhathi ezingenhla zishaywe indiva.

7.5. Inhlanguano izonikeza umfakisicelo isaziso esibhalwe phansi ngesinqumo sayo sokuthi isicelo sivunyiwe, leso saziso esibhaliwe esizofaka nezizathu zokwenqaba leso sicelo, uma leso sicelo senqatshwa.

7.6. Izinsuku ezingama-30 (ezingamashumi amathathu) ezishiwo zingase zelulwe kwesinye isikhathi esingeqile ezinsukwini ezingama-30 (amashumi amathathu) uma isicelo singesenani elikhulu lamarekhodi, noma isicelo sidinga ukuphenywa kolwazi olungeke lutholakale Phakathi kwezinsuku ezingashumi amathathu Umlawuli wolwazi uzokwazisa umfakisicelo ngokumbhalela uma kwenzeka kucelwa ukuba angezelelwe isikhathi.

7.7. Uma isicelo senziwa egameni lomunye umuntu, lowo mfakisicelo kufanele alethe, ngendlela eculisa iNhlangano, ubufakazi begunya umfakisicelo enza ngaso isicelo.

7.8. Uma umuntu engakwazi ukuhambisa isicelo ngefomu elinqunyiwe ngenxa yokungakwazi ukufunda nokubhala noma ukukhubazeka, lowo muntu unelungelo lokufaka isicelo ngomlomo.

7.9. Umfakisicelo kudingeka ukuthi akhokhe imali enqunyiwe, futhi afake imali ekhokhwa kuqala lapho kufanele khona, ngaphambi kokuthi isicelo sicutshungulwe.

8. UKUFINYELELA KUMAREKHODI

9.2. Izindlela zangaphandle

Umfakisicelo noma umuntu wesithathu, ongagculisekile ngesinqumo seNhlangano (ekuqaleni noma ekudlulisweni kwesikhala) maqondana nesicelo sokuthola irekhodi, ezinsukwini ezingama-30 (amashumi amathathu) zaleso sinqumo angafaka isicelo eNkantolo Ephakeme, noma iyiphi enye iNkantolo enegunya, ukuze asizakale.

10. IZIMALI

- 10.1. Uma isicelo samukelwe yiNhlango izodinga ukuthi umfakisicelo, ngesaziso, ngaphandle kwesicelo somuntu siqu esenziwe maqondana namarekhodi lomuntu siqu, akhokhe imali yesicelo enquuniwe (uma ikhona), ngaphambi kokuthi kuqhutshewo nokucubungula isicelo.
- 10.2. Uma ukufunwa kwerekhodi kwenziwe futhi ukulungiswa kwerekhodi ukuze lidalulwe kuzodinga isikhathi esengeziwe kunaleso esibekelwe , Isikhulu Esibhekele Ulwazi sizokwazisa umfakisicelo ukuthi akhokhe, njengesibambiso, ingxenye enquuniwe yemali yokuthola ulwazi. izobe isikhokhwa uma isicelo samukelwe.
- 10.3. Inhlango izogodla irekhodi kuze kube lowo ofake isicelo usekhokhe izimali ezinqunyiwe kanye nemali ekhokhwa kuqala, lapho kufanele.
- 10.4. Umfakisicelo osicelo sakhe sokuthola irekhodi samukelwe, kufanele akhokhe imali yokufinyelela ukuze likhiqizwe kabusha kanye nokulibheka nokulungisa, kanye nesikhathi esidingekayo esingaphezu kwamahora anqunyiwe ukubheka nokulungiselela irekhodi ukuba lidalulwe.
- 10.5. Uma imali ekhokhwa kuqala ikhokhiwe mayelana nesicelo esinqatshiwe, iNhlango izobuyisela leyomali kumfakisicelo.
